Entries: Entries are due at 6:00 p.m. on May 31st, 2010

The draw determining the running order will be held at 6:00.

An **official entry form** must be completed for each dog entered in each category. This is a DOUBLE event with separate entry forms. Photocopies of the enclosed entry form are acceptable. General Information

1. Entries must be made in advance and sent with all entry fees. One dog per entry form and event. Make checks payable to **Okoboji Retriever Club**.
2. Please **print clearly/type**, complete all sections of the **official entry form**, make checks payable to Okoboji Retriever Club, and mail to Mike Anderson, 404 23rd Street , Spirit Lake, IA 51360.
3. Refunds are available for scratches made prior to the closing date, bitches in season, and injured dogs. Requests for refunds must be accompanied by a written vet statement stating the reason for withdrawals.
4. The Field Test will be conducted in accordance with NAHRA regulations.
5. Bitches in season are not allowed on the test grounds.
6. No consumption of alcoholic beverages is allowed on the test grounds during the field test.
7. Dark or camouflage clothing is required for all handlers, spectators, and helpers.
8. Training aids may be used **ONLY** in designated areas.
9. Drive only on designated roads or areas on test grounds and pick up trash.
10. Handlers will provide their own duck/goose calls and hip boots/waders.
11. Spectators and other handlers will be required to keep noise and distractions to a minimum when a Handler and Dog are running a test.
12. Food and beverages will be available on the test grounds for lunch on Saturday and Sunday with the banquet on Saturday evening.

CHECK IN

Handlers must check in with the FT Secretary at the field test headquarters before they run their dogs. The Field Test Headquarters will be at Ike Petersen Farm.

SATURDAY BANQUET

- Saturday night banquet & Awards will be held at Fort Defiance, (near Estherville, IA) 30 minutes after the last dog runs or 6:00 p.m.
- Price is \$10.00 per Adult & \$5.00 for Children under 14 years of age.
- Please include a check for meal prices with your entry and the number of adults and children.
- Ribbons will be presented to qualifying dogs and the banquet will be followed by a raffle.

TEST SITE DIRECTIONS

Directions to Ike Petersen Farm are as follows:

From Estherville: Take Highway IA-4 south out of Estherville for approximately 6.5 miles; turn west on A34 for 1 mile; turn south on 390th Avenue, drive 3.5 miles. Test site is on the west side of the road..

From Graettinger: Take Highway IA-4 north out of Graettinger for approximately 1.3 miles; turn west on 270th Street for 2.7 miles; turn north on 390th Avenue for .2 miles. Test site is on the west side of the road.
